#### Description

1. The Tarlac State University, through Special Budget (SB) 2024 intends to apply the sum of Nineteen Million Nine Hundred Ninety Eight Thousand Four Hundred Eighty and 53/100 Pesos (₱ 19,998,480.53) to payments under the contract for the project: Refurbishment of Multi-Purpose Sports and Wellness Center.

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Tarlac State University now invites bids for the aforementioned Project. Completion of the Works is required within one hundred eighty calendar days (180) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non- discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
