**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE
BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT**

APPROVED BUDGET FOR THE CONTRACT (ABC): **₱ 10,575,000.00**

WHEREAS, the Tarlac State University advertised the Invitation to Bid for the project Supply and Delivery of College Uniforms (APP 2023) with an Approved Budget for the Contract (ABC) of ₱ 10,575,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on February 10, 2023;

WHEREAS, in response to the Invitation to Bid, five (5) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on February 17, 2023;

WHEREAS, in the public bidding held at the Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on March 1, 2023, at 2:00 P.M.:

- (a) Three bidders, namely, England Textiles, Zhujar Manufacturing Inc., and Woman Fine Clothing, Inc., tendered their bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the three bidders, using the non-discretionary "pass/fail" criterion, and found that the first envelopes of the three bidders contained all the required documents and were rated "passed".
- (c) the BAC, with the assistance of the TWGs, checked the second envelopes of the three bidders and found that the envelopes complied with the requirements and were rated "passed",
- (d) the BAC, with the assistance of the TWGs evaluated and ranked the bids of the three bidders,
- (e) the BAC resolved to declare England Textiles, as the bidder with the Lowest Calculated Bid (LCB) for Lot No. 1 with the bid price of ₱ 4,780,000.00,
- (f) the BAC resolved to declare Zhujar Manufacturing, Inc., as the bidder with the LCB for Lot No. 2 with the bid price of ₱ 3,836,160.00,

- (g) the BAC resolved to declare Zhujar Manufacturing, Inc., as the bidder with the LCB for Lot No. 3 with the bid price of ₱ 759,000.00, and
- (h) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCBs;

WHEREAS, in the Post-Qualification Evaluation Conference held at the Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on May 2, 2023:

- (a) the TWG for the Legal and Financial Aspects reported that the LCBs for Lot No. 1, Lot No. 2, and Lot No. 3 were responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for the Technical Aspect reported that the LCBs for Lot No. 1, Lot No. 2, and Lot No. 3 were responsive to the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCBs for Lot No. 1, Lot No. 2, and Lot No. 3 as responsive, and
- (d) the BAC resolved to recommend to the President the Award of Contract for Lot No. 1 to England Textiles and the Award of Contracts for Lot No. 2 and Lot No. 3 to Zhujar Manufacturing, Inc.;

WHEREAS, in the 130th Regular TSU BOR Meeting held on June 29, 2023, the Board of Regents passed BOR Resolution No. 80, s. 2023, approving the Award of Contracts to the winning bidders for the project Supply and Delivery of College Uniforms (APP 2023) as recommended by the BAC;

WHEREAS, in compliance to BOR Resolution No. 80, s. 2023, the Notices of Award of Contracts were prepared and given to England Textiles for Lot No. 1 and Zhujar Manufacturing, Inc. for Lot No. 2 and Lot No. 3 of the project Supply and Delivery of College Uniforms (APP 2023) on July 6, 2023;

WHEREAS, the BAC found out that Zhujar Manufacturing, Inc. was included in the list of blacklisted suppliers that was posted by the Government Procurement Policy Board on its website on July 12, 2023;

WHEREAS, Clause 2.0 of Appendix 17 of the IRR of R.A. 9184, states that: *A person/entity that is blacklisted by a procuring entity and/or included in the Government Procurement Policy Board ("GPPB") Consolidated Blacklisting Report shall not be allowed to participate in the bidding of all government projects during the period of disqualification unless it is delisted as provided for in these guidelines;*

WHEREAS, Section 23.6 of the IRR of R.A. 9184 states that: *Notwithstanding the eligibility of a bidder, the Procuring Entity concerned reserves the right to review the qualifications of the bidder at any stage of the procurement process if the Procuring Entity has reasonable grounds to believe that a misrepresentation has been made by the said bidder, or that there has been a change in the bidder's capability to undertake the project from the time it submitted its eligibility requirements. Should such review uncover any misrepresentation made in the eligibility requirements, statements or documents, or any changes in the situation of the bidder which will affect the capability of the bidder to undertake the project so that it fails the eligibility criteria, the Procuring Entity shall*

consider the said bidder as ineligible and shall disqualify it from obtaining an award or contract, in accordance with Rules XXI, XXII, and XXIII of this IRR;

WHEREAS, due to the discovery that Zhujar Manufacturing, Inc. is blacklisted and is therefore ineligible to participate in a public bidding as prescribed in Clause 2.0 of Appendix 17 of the IRR of R.A. 9184, and in accordance with Section 23.6, the BAC, in the Meeting held on August 2, 2023;

- (a) unanimously agreed to belatedly declare Zhujar Manufacturing, Inc. ineligible to bid for the project Supply and Delivery of College Uniforms (APP 2023) and
- (b) resolved to recommend to the President the cancellation of the Award of Contracts that were given to Zhujar, Manufacturing, Inc. for Lot No. 2 and Lot No. 3 of the project Supply and Delivery of College Uniforms (APP 2023);

WHEREAS, on August 15, 2023, the Board of Regents passed Referendum No. 385, s. 2023, approving the cancellation of the Award of Contracts for Lot No 2 and Lot No 3 of the project Supply and Delivery of College Uniforms (APP 2023) that were given to Zhujar Manufacturing Inc.;

WHEREAS, the BAC immediately directed the BAC Secretariat to inform Zhujar Manufacturing, Inc. of the decision of the Board of Regents to cancel the Award of Contracts for Lot No. 2 and Lot No. 3 of the project Supply and Delivery of College Uniforms (APP 2023) that were given to them and directed the TWGs to proceed with the post-qualification evaluation of the bids of Woman Fine Clothing, Inc., the bidder with the next Lowest Calculated Bids;

WHEREAS, in the Post-Qualification Evaluation Conference held on October 27, 2023:


- (a) the TWG for the Legal and Financial Aspects reported that the bids of Woman Fine Clothing, Inc. for Lot No. 2 and Lot No. 3 complied with the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for the Technical Aspect reported that the bids of Woman Fine Clothing, Inc. for Lot No. 2 and Lot No. 3 complied with the technical requirements for the project as prescribed in the Bidding Documents, and
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the bids of Woman Fine Clothing, Inc. for Lot No. 2 and Lot No. 3 as responsive;

THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- (a) to declare Woman Fine Clothing, Inc. as the bidder with the Lowest Calculated and Responsive Bids for Lot No. 2 with the bid price of ₱ 3,860,320.00 and Lot No. 3 with the bid price of ₱ 831,000.00, and
- (b) to recommend to the President the Award of Contracts for Lot No. 2 and Lot No. 3 of the project Supply and Delivery of College Uniforms (APP 2023) to Woman Fine Clothing, Inc.







WHEREAS, the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and checked the first envelopes contained in the bids submitted by the three bidders, using the non-discretionary "pass/fail" criterion, and found the first envelopes of the three bidders to contain all the required documents and were rated "passed";
