Description

Bids received in excess of the ABC for shall be automatically rejected at bid opening.
- 2. The Tarlac State University now invites bids for the project Supply and Delivery of Desktop Computers for the College of Computer Studies (APP 2024). Delivery of the Goods is required within thirty (30) calendar days from the receipt of the Notice to Proceed.
