5. The Tarlac State University, through its Bids and Awards Committee now invites interested suppliers to the negotiations which shall be held on October 13, 2022 at 2:00 P. M. at the TSU Business Center AVR and via Zoom (Meeting ID:897 7027 5514, Passcode: 148993.

6. Prospective suppliers must be Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to R.A. 5183.

7. Pursuant to Section IV (G) of the Guidelines in Annex H of the Revised Implementing Rules and Regulations of R.A. 9184, a Certificate of PhilGEPS Registration (Platinum Membership) shall be a mandatory eligibility requirement for this procurement project.

8. The negotiations shall focus on the project requirements and guidelines, in accordance with the procedures prescribed in Annex H of the Revised Implementing Rules and Regulations of R. A. 9184 for Negotiated Procurement Due to Two Failed Biddings.
